Extracts from Impact Statements in speech marks (")

001. Loss of family home by failure of multiple Executives of HM Administration. Police have refused to receive evidence and to investigate.

Essex

"Cruel process, hurt and cheated. Spiteful, thugs, frightened, shocked, torturous, abuse "

002. Engineered Bankruptcy by Bank resulted in the loss of Complainants business and home. Police have refused to receive evidence and investigate.

Berkshire

- "Cruel, degrading, inhumane treatment, abuse of human rights, stress, anxiety, insomnia, despair, mental torture, loss of dignity, abused, panic, relationship breakdowns, nightmare, coronary heart disease"
- 003. Entrapment by vicious spiral of unnecessary short term bridging loans destroying LTV, breaches of fiduciary duty, undisclosed conflicts of interest, only exit route repossession. Combined actions of the police, lenders, broker and others resulting in the destruction and loss of family home, business, income, assets and family unity. Police have refused evidence and to investigate for over fifteen years.

Yorkshire

- "Extreme stress, mental trauma, committing suicide, isolated, relationship strains and breakdown, humiliation
- 004.Secret Commission where Lender promised temporary bridging which the broker failed to convert to affordable lower rate debt funding causing attack to repossess the farm. Police have refused to receive evidence and to investigate.

Carmarthenshire

- "Immeasurable stress and anxiety, suicide attempts, depression, broken marriage, constant fear, self respect wiped away"
- 005. Multiple undisclosed conflicts of interest, deception, misrepresentation and State failure leaving the family distraught. Police have refused to receive evidence and to investigate for over twenty years.

Cumbria

- "Shattered, scared, mental torture, humiliation, devastated, lives ruined, severe and profound effect on my mental health, lost confidence, anxious"
- 006. Malfeasance by Bank, breaches of fiduciary duty and trust by Bank. Bank CEO admitted the Bank was in dire financial straits and apologised for the Banks actions but no remedial action was offered or taken by the Bank. Police have refused evidence offered and to investigate.

Somerset

" Mental breakdown, hypertension "

007. Bait and switch by lender, breaches of fiduciary duty, failure by police to receive evidence and investigate resulting in loss of family home and business. Police have refused to receive evidence and to investigate.

East Lothian Scotland

"Serious problems in our marriage, intent to take my own life, severe PTSD, depression"

008. Victim of Banking hidden agendas resulting in the loss of over 700 properties and a substantial business of UK's former second wealthiest lady entrepreneur. Police have refused to receive evidence and to investigate.

London

- "Devastating impact on my mental and physical health, severe hypertension, risk of cardiovascular event (stroke or heart attack) severe depression, suicidal thoughts"
- 009. Breaches of fiduciary duty, undisclosed conflicts of interest, misrepresentation, bait and switch, deception, succession of unnecessary expensive short term bridging loans to destroy loan to value ratio. Lender restrained from repossession until youngest child eighteen years of age then continual harassment. Police have refused to receive the evidence and to investigate for over fifteen years.

Kent

- "Mental breakdown, counselling, stress, depression, mental torture, mentally painful, breaking under pressure, lack of sleep"
- 010. Interlocutory actions of lenders, broker, solicitors and valuers by concealment, overcharging, twisting and distorting of facts, baiting and misrepresentation resulting in loss of farm and business. Police have refused to receive evidence and to investigate for over twelve years.

South Wales

- "Severe depression, unable to sleep, high blood pressure, reclusive, Chaplain (Church) support"
- 011. 30 years of marriage gone. Family destroyed by a personal guarantee through deceit and abuse of position by the Bank and their receivers. Failure of Police, Courts and Ministers caused family mental torture. The State failed the victims. Police have refused evidence and to investigate.

Kent

- "Anxious, depressive, intense horror, sadness, bewilderment, attempted suicide, mood and character change, extremely distressing, self harm, extreme shock, terrified, deprived of sleep, insomnia, blackness, destroyed, pressure, mentally scarred, phobias, severe depression, torture, mental illness, anxiety"
- 012. Loss of everything including marriage and future stability of family following attack by Lender. Police have refused evidence and to investigate.

Staffordshire

"Run down, low mood, irrational, depressed, high blood pressure, hell, angry, lack of motivation, soul destroying"

013. Loss of Landscaping business and all assets by criminal actions of others. Failure by police to receive evidence and investigate.

Norfolk

- "Excruciating worries, stress, massive shock, felt useless, anxious, couldn't sleep, traumatised, excruciating worries"
- 014. Loss of substantial property business and family home due to sudden withdrawal without warning of banking facilities and drive by Lender to liquidate customers assets destroying in conjunction with Bank appointed Receiver, thirteen years' work by customer and his family. Trustee of complainants bankruptcy threatened Senior Counsel of customer. Police have refused evidence and to investigate.

Glasgow Scotland

- " Mental pressure, hunger strike, sleepless nights, stress, nightmare"
- 015. Lender Engineered shortage of promised funding to collapse their customer and asset strip taking all equity and assets leaving his client distraught and penniless which severely impacted on customers daughters health and personal financial position. Police have refused to receive evidence and investigate for over fifteen years.

N.W Wales

- "Stress, severe depression, anti-depressants, exacerbated diabetes, mental torture, PTSD, suffer "
- 016. Consequences of unlawful financial practices uncovered committed against an Associate reported to the Police who took no action

Norfolk

- "Severe chest pains, doesn't sleep properly, head feels pressure and like it's going to blow up, gaslighting, mental effects"
- 017. Loss of all assets including shopping mall, bait and switch, undisclosed conflicts of interest, payment of secret commission by lender to broker, breaches of fiduciary duty, deception, breaches of Consumer Credit Act, breaches of Law of Property Act 1925. Court abuse. Police have refused to receive evidence and to investigate for seventeen years

Hampshire

- "Very depressed, anxiety, stress, anger, frustration, ongoing depression, despair, horrific, destroying my life, suffered mentally, emotionally, physically, devastating, I wanted to give up, grief, losing confidence, Non Hodgkin's Lymphoma, muscle medical problem, Sjogren's Syndrome, stroke, ashamed"
- 018. Marriage and £8 million property portfolio and eleven micro companies worth £1.5 million destroyed due to the action of finance company withdrawing support and HMRC and UK pension industry filing for bankruptcy. Police have refused evidence and to investigate.

Manchester

"Allocated suicide watch doctor, DVT, diabetes, heart medication, physical assaults, going physically hungry, made to look unprofessional and foolish in front of a judge, bullied, harassed, assaults, threats, threatening, abuse, destroys lives"

019. Farming business crippled by undisclosed conflicts of interest between solicitors, mortgage brokers and lenders, secret commissions, breaches of fiduciary duty, bait and switch, deliberate creation of vicious spiral of unnecessary debt to destroy LTV creating repossession as being the only exit route. Police have refused to receive evidence and investigate for eighteen years

Cornwall

- "Detrimental impact on our livelihood, health and wellbeing, worry, stress, continued burden, mental health really deteriorated, severe depression, counselling, suicide candidate, recluse, heart and blood pressure problems, bowel cancer, severe migraines, two TIA's, mental health, huge toll on our physical and mental health, prolonged suffering "
- 020. Allegations of abuse and contempt of criminal law, common law and Human Rights by His Majesty's PM and Cabinet Executives in Government Administration. From 1990 there has been a total and continuing failure of police jurisdiction and procedure to enforce the law in contempt of His Majesty's Royal Assent as ratified by and enforced by Parliament prescribed by the Bill of Rights 1688/1689. Premeditated abuse and it's maintenance to ensure a perpetual state of bankruptcy. Failure of the Police to receive evidence and investigate police and judicial corruption for over thirty years.

Withheld

- "Threats to kill by criminal making payments (bribes) to police and court ignored by police, denial of protection of the law and security, intimidation, false arrest, false imprisonment and solitary confinement, assault and battery whilst imprisoned occasioning hospitalisation, malicious intention to Section under Mental Health Act, prolific torture, inhumane and degrading treatment "
- 021. Loss of farm by succession of unnecessary short term bridging loans to destroy LTV, bait and switch resulting in only exit route being repossession, undisclosed conflicts of interest, breaches of fiduciary duty. Police have refused evidence and to investigate for over ten years.

Moray Scotland

- "Tremendous stress, completely lost, high blood pressure, stroke, 3 TIA's, diabetes, life completely changed and turned upside down, upset, extensive, feeling vulnerable, effected m emotionally and mentally, traumatising, depressing, lost confidence, embarrassment, shame, awful, mental and physical health impacted, unnerving, panic, devastating, degrading, deterioration of health and wellbeing, traumatising "
- 022. Interlocutory actions of Lenders, Police, Solicitors acting as a cartel resulting in the total loss of all assets including farm and family home and destruction of victims lives and wellbeing of the family. Police have refused to receive evidence and to investigate for over thirty years.

Cornwall

"Massive shock, full of worry, unsure, felt shame, embarrassed to socialise, fear, frustrating, emotions, anger, hatred, afraid, anxiety, dreaded, mentally exhausted, traumatic, stress, severely haemorrhaging, blood transfusions, pressure, Non-Hodgkin's Lymphoma, painful "

023. Interlocutory unlawful actions of Bankers, their associates and police resulting in total loss of farm and personal assets. Police have refused to receive evidence and investigate for over 30 years.

Cornwall

"Threatened, bully, demands, constant worry, pressure, stress, heart attack, awful migraines, high blood pressure, depression, anxiety, cancer, extreme strain, problems sleeping, felt totally drained, tension, headaches, upset"

024. Interlocutory actions of police, solicitors, valuer and broker acting unlawfully. Secret commission paid by lender to broker. Police have refused to receive evidence for over 25 years and to investigate.

North Wales

- "Stress, continuous post traumatic stress disorder, insomnia, severe depression, supported by Mental Health Service, pressure, anxiety, shingles"
- 025. Bank refusal to fulfil / inability to fulfil their financial obligations resulting in collapse of business and resultant trauma for customer and his family. Police have refused to receive evidence and investigate.

Gloucestershire

- "Malicious, inhumane, harassment, bullying, mental trauma, torment, anti- depressants, agonies, mental torture, rifts within my family, mental anguish, despicable, traumatising, upsetting, heart breaking, dispiriting, depressed, anger"
- 026. Bank paid monies from customers business without customers knowledge or authorisation resulting in collapse of business and loss of everything. Police refuse to receive evidence and investigate.

Staffordshire

- "End our lives to relieve the pain in our heads, tears, broke down, constant stress, extremely upsetting, grief, constant attack, paramedics to our house because they were worried about our mental health, psychologically harmed, mental breakdown, systemic attack, immense suffering, upset, harassment, mental abuse, broken mentally, mentally raped"
- 027. Interaction of Lenders, Police, Solicitors, LPA Receivers, Accountants and Associated professionals involved in the handling of victims legal and financial affairs showing their entrapment of the family, police failure, twisting of facts to the detriment of the complainants, refusal of evidence available, concealment and laws broken. All acting as a cartel to pervert justice resulting in loss of family farm. Police have refused to receive evidence and to investigate.

Somerset

"Trauma, unlawfully wicked, cruel, serious friction, stress, haunting memories, depression, threatening, dangerously high blood pressure, fearing she had committed suicide, mental health issues"

028. Unlawful actions by Bank Manager caused collapse of property development business and saw a criminal gain a suspended prison sentence but despite this the Bank have relentlessly pursued complainants for monies unlawfully paid by the Bank to others. Police have refused to receive evidence and investigate.

Cornwall

"Traumatised, post-traumatic stress syndrome, suffered mentally and physically, miserable, stress, severely depressed, counselling, threatened suicide, under suicide watch, bully, harassment, cancer, mental illness, stress, mental torture"

#### 029. Police refused evidence and to investigate Perjured Affidavit

London

- "PTSD, affected my physical and mental health, immense stress, cancer, suffered immensely"
- 030. Unlawful action by Bank related to former Wife resulting in years of harm both mentally and physically and unjust attack on property and loss of all assets supported by the actions of the Police who have apologised for the abuse suffered but deny responsibility and to pay restitution to complainant.

Somerset

- "Inflicted psychological injury, mental and physical harm, prolonged abuse, torturous, abuse, suffered, Post Traumatic condition, PTSD, trauma, State took away my liberty, comatose by psychiatric drugs for a psychiatric illness I never had, bullying, they apply for a sectioning order...... upon a later proven misdiagnosis, retraumatised, psychological assaults, subject to hostile questioning, my life and sanity have been abused"
- 031. Bank Engineered loss of four properties and all assets yet Government Agencies including the Police refuse to receive evidence of wrongdoings and investigate.

Hampshire

" Mentally over whelmed, helpless, hopeless, felt living in Nazi war film, sad feeling, alone, isolated, fear of attack, trauma, mental torture, frustrated, loss of confidence, feelings of suicide. panic attacks, broken, physically sick, devastated, lost my identity, wrecked self- esteem, counsellor, assault, depressive, no energy, painful, PTSD, feel unsafe, lack of trust, attack, suffered, destruction, could not focus, barely concentrate, turmoil. depressed, shock, horror, unconscious, assaults, bullying, mental block, heartache, bombarding, threats, abuse, overwhelmed. helpless, hopeless, chest pains, high stress, low moods, low motivation, panic attacks, terrifying, flash backs, nightmares, very high anxiety, not feeling safe, trouble sleeping, break down, ABH, GBH, suffering, life changing, attack, stalked, menacing, worrying, migraines, headaches, palpitations, sadness, mental and emotional distress, physical injuries, terrorised, dreadful, broken. great impact on my welfare, suicidal, surreal numbness, polarised, PIP for depression"

032. Dishonest Solicitors who routinely lie in Court following unlawful action by the Bank. Police refuse to receive evidence of Bank and their Associates wrongdoings and investigate.

"Abuse, mental torture, abuses, mental harm, attacks, bombarded, threat of jail, destroy, devastating, break the spirit, mountain of stress, anxiety, headaches, migraines, overwhelming stress affecting sleep affecting ability to work, deep sadness, depression, bed-ridden with anxiety, panic attacks, dark thoughts to end it all, immense pain inflicted, bully-boy tactics, serious harm, continual abuse"

033. Nefarious Bank and Associated practices resulted in loss of substantial highly profitable business in the Hospitality Trade employing 240 staff and all personal assets. Police refuse to receive evidence and to investigate.

Sussex

"Stress, trauma, immense impact and pressure, distressed"

034. Loss of business and all personal assets due to illegal accountancy practices. Police refuse to receive evidence and investigate unlawful action by Bank and IVA Receiver.

Cambridgeshire

"Worry, bullying, stress, hell, pain"

035. Unlawful actions by Bank and their associates targeting and destroying family building business. Police refuse to receive evidence and to investigate.

Herefordshire

- "Devastating impact, mental health badly damaged, callous, threatening, constant pressure, chronic anxiety, trauma, destructive of marital harmony, referrals to crisis unit of Hospital, Transient ischemic attacks (mini strokes), complex post-traumatic stress disorder, duress, insulted, diminished, humiliated, abusive, menacing, torture, premeditated attack, acute stress, chronic anxiety and trauma, poor bowel and urinary function, panic attacks, acute anxiety, fear, anger, intentional mistreatment, major breakdown, mental illness, acute depression, pressure"

- "Abuse, cruel mental torture, degradation, physical illness, severe depression, traumatised, insult, pain, trauma, horrendous, severe anxiety, panic attacks, unbearable, terrifying, had strong urges to ...... end my anguish, numerous sessions with therapist "
- 037. Due to a Non Disclosure Agreement Complainant passed his case evidence of criminal wrongdoings directly to the Police who took no action.

South Wales

"Mental strain, constant worry, enslaved, the stress is unbearable, daily stress, abused "

038. Bait and Switch, breaches of fiduciary duty and trust. Broken promises by Bank. Failure by Bank to fulfil agreed facilities after customer had committed to expansion of farming business which financially crippled the farming family.

West Wales

Suicide Letter "I am sorry you are reading this, I cannot keep living like this anymore I just feel so low and alone and ashamed of myself it's time to say goodbye I love you both so much it hurts you know I will be looking down on you both always. I just cannot fight anymore but at least I will be with dad looking down on you to . Love you both forever XXX "

039. Destruction of Estate Agency Network and industry advisor stakeholder by successive failure of the Police and other State Executives to receive evidence and investigate criminal actions of the Bank and their associates.

Kent

- "Life is hell, immense stress and pressure, daily abuse, living nightmare, constant fear, cruel, inhumane, contemplated overdosing, traumatised, high stress, insomnia, high blood pressure, hot sweats, heart attack, eating disorder, duress, misery and pain, anxiety, continual fear, stalking, harassment, cruel, inhumane, immense stress, dragged into Court 23 times, frustration, torture, distressing, trauma, lost friends, suicidal thoughts, career destroyed, malicious arrest, threat of mental health assessment by police, loss of social life/ interaction, traumatised, tiredness, constant anxiety"
- 040. Failure of police to receive evidence of theft of family home and unlawful collapse of business by Bank through false fees and valuation rigging . Police have refused to receive evidence and to investigate for over ten years.

"Acts of terrorism and torture, Son manhandled from house, Continuing Post Traumatic Stress Disorder, distresses, Son said "If I kill myself will the Authorities do something for you and my Sisters", trauma induced ME, OCD with intrusive thoughts, Crohn's Disease exacerbated by stress, introverts, distress, nightmares, flashbacks, existing for the sake of existing, IBS and pancreatic insufficiency and severe mental social anxiety"

041. Victim of financial misconduct by Lenders.

Glasgow Scotland

Committed suicide. Hanged himself in garage

042. Victim of unlawful securitisation of mortgage charge created by Bank using false paperwork. Evidence refused by the Police.

Edinburgh Scotland

"Trauma, psychological impact, questions one's sanity, threatened, blind panic, psychologically unbearable, suicidal, therapy, cold sweat, anxiety, suffer, insomnia, maliciously, wickedness, soured relationship, deeply disturbing, major impact, ignominious, demoralising"

043. False paperwork lodged into Court by Solicitors to secure repossession of and eviction from family home assisted by the Police who refuse to receive the evidence and investigate.

Surrey.

- "Profound and lasting effects of the systemic abuse, mental health consequences, damage inflicted on families, relationships and well-being, Abuse, mental anguish/ torture, emotional distress, adverse effects on mental health, constant harassment, mistreatment, feeling helpless, fearful, struggled, depression, contemplated suicide, ordeal, strain, stress, rifts, tension, breakdown, relentless anguish, traumatic, chronic stress, sleep disturbances, fatigue, weakened immune system, emotional turmoil, headaches, gastrointestinal issues, abuse, degrading, humiliating, feeling vulnerable, systemic abuse, devastating effects, inhumane treatment"

- "Hospitalised due to stress, tortuous ordeal, systemic destruction, high levels of stress, break me, deprivation, huge impact, breakdown, torturous, shock, destroy, pure torture"

- "Suffering increasing stress and anxiety symptoms, depression, impact on stress levels, impact on mental health, personal stresses"
- 050. Loss of farm due to unlawful interaction of lender and LPA Receiver , false allegations of animal cruelty and threats of which police refused to receive the evidence and investigate.

Surrev

- "Suffer, mental torture, insecurity, physical illness, harassment, 250 hours community service due to unlawful prosecution, stress, feeling of being insignificant"
- 051. Bank BSU Manager engineered contractual default to cause collapse and asset strip. Police refused to receive evidence and investigate.

- "Multiple referrals and admissions to hospital for CVA, hypertension, TIA's, critical asthma attack, bladder cancer, psoriatic arthritis, adverse effect on social activities through depression, reclusive, daughter underwent a divorce with its roots in our situation, suffered deep depression, collapsed requiring CPR, admitted to hospital"
- 053. False or no paperwork used by Bank and their Agents to seize assets of haulage business. Police refuse evidence and to investigate.

Oldham

- "Attack, health and well being constantly abused, human rights violated, terror, intimidation, misery, suffering, reign of terror, constant state of distress, under siege, depressed, suffered Bell's palsy, sexually assaulted my son, pressure, shocking, terror, negative affect on my mental and physical well-being, outrageous, fighting weekly if not daily, blackmail, inhumanely failed "
- 054. Destruction of Property developer and landlord by unlawful systemic attack by Lender and their associates. Police refuse evidence and to investigate.

Middlesbrough
